## ORDINANCE NO. 766

AN ORDINANCE AMENDING CITY OF GRAYVILLE ORDINANCE NO. 689, BEING AN ORDINANCE REGULATING GOLF CARTS WITHIN THE CITY LIMITS OF THE CITY OF GRAYVILLE

WHEREAS, the City of Grayville Board of Commissioners passed Ordinance No. 689 on August 13, 2007, entitled, "An Ordinance Regulating Golf Carts within the City Limits of the City of Grayville", which ordinance was incorporated into the Grayville Code of Ordinances as Sections 73.30 through 73.32; and

WHEREAS, Ordinance No. 689 did not specifically authorize the use of "recreational offhighway vehicles" on city streets and approved state roads within the City of Grayville; and

WHEREAS, the Board of Commissioners of the City of Grayville finds that the regulated use of "recreational off-highway vehicles" is consistent with the objectives and purposes addressed by Ordinance No. 689;

NOW THEREFORE, be it ordained that Section 1 of Ordinance No. 689 and Section 73.30 of the Grayville Code of Ordinances shall be amended to read as follows:

## 1. DEFINITIONS

As used in this chapter:

A "golf cart" shall include those vehicles defined in 625 ILCS 5/1-123.9, being a vehicle specifically designed and intended for the purposes of transporting one (1) or more persons and their golf clubs or maintenance equipment while engaged in the playing of golf, supervising the play of golf, or maintaining the condition of the grounds on a public or private golf course, and for the sole and limited purpose of this ordinance, shall also include those vehicles that would otherwise be defined as a "recreational off-highway vehicle" in 625 ILCS 5/1-168.8, being any motorized off-

highway device designed to travel primarily off-highway, 64 inches or less in width, having a manufacturer's dry weight of 2,000 pounds or less, traveling on four (4) or more non-highway tires, designed with a non-straddle seat and a steering wheel for steering control, except equipment such as lawnmowers. The definition of a golf cart for purposes of this ordinance specifically excludes all-terrain vehicles (ATV's), off-highway motorcycles, and any other vehicle that is not otherwise defined herein as a golf cart.

In all other respects, Ordinance No. 689 and Sections 73.30 through 73.32 of the Grayville Code of Ordinances are ratified, republished, and incorporated as if fully set forth herein.
